# Shelby County, Iowa New Job Creation Incentive Plan FY2018

Shelby County shall participate in a "New Job Creation Incentive Plan" targeted to small and entrepreneurial businesses (businesses with 10 employees or less at time of application) in Shelby County, Iowa. The purpose of this plan is to encourage/support new and existing businesses in Shelby County in their efforts to expand their workforce. Businesses in Shelby County will complete an <u>application</u> for the program. The application will indicate the number of planned jobs to be created the Company is seeking incentive for. The program will be limited to a maximum of twenty-five (25) jobs created within each fiscal year. The New Job Creation Incentive Plan is set forth as follows:

- 1. Shelby County will establish a budget of \$25,000 in the fiscal year to establish the Plan. Upon demand, Shelby County agrees to pay the Company the sum of \$1,000 per new full-time job created and maintained for the period of two (2) years. If those full-time employees have been residents of Shelby County for one year or more, the County agrees to pay the Company the sum of \$2,000 per new full-time job created and maintained for the period of tow (2) years. Full-time is defined by the IRS (Internal Revenue Service) as anyone working an average of thirty (30) or more hours per week over a 12-month period.
- 2. To qualify, all newly created jobs must be maintained for two (2) years and increase the Company's current number of employees at time of application to the Plan.
- 3. Another "New Job Creation Incentive Plan" is in place to address any company that create more than 25 jobs in one year.
- 4. Documentation of employee count and residency, as indicate on the initial application, will be required upon payment demand to certify the full-time status for the two (2) year period.
- 5. Once the documentation has been provided and approved by the Board of Supervisors, a check for \$1,000/\$2,000 per job created for the application will be issued within 30 days.
- 6. All terms and conditions for the New Job Creation Incentive Plan shall be put forth in the form of a written agreement to be prepared by the Shelby County Attorney.

# "The Equifax Data Breach: What You Should Be Doing"

On 09/07/17 Equifax, one of the country's three biggest credit reporting agencies (CRA) reported that it experienced a monumental data breach. We now know that the sensitive, personal data of 145.5 million Americans' has been compromised. The Federal Trade Commission (FTC), which regulates credit, reports that "names, Social Security numbers, birth dates, addresses, and in some cases driver's license numbers" were exposed. They also stole 209,000 people's credit card numbers.

So what should you do? Here are some bullet points to start with:

- \*Equifax has set up a site, <a href="https://www.equifaxsecurity2017.com/">https://www.equifaxsecurity2017.com/</a> to help keep consumers current on the aftermath, as well as provide some tools. Equifax is providing free ID monitoring service by going to the What Can I Do section of the site and enrolling in their TrustedID Premier service. This includes credit monitoring of your Equifax, Experian, and TransUnion credit reports; copies of your Equifax credit report; the ability to lock and unlock your Equifax credit report; identity theft insurance; and internet scanning for your Social Security number all complimentary to U.S. consumers for one year. You have until 01/31/18 to enroll in this service.
- \*Update ALL of your passwords. Passwords need to be long, complex, and unique. Wherever possible, create "out of wallet" questions for your accounts. These are questions that someone theoretically finding your wallet (or in this case, your credit report) wouldn't be able to answer using the information therein.

- \* Ask one of the three CRAs to put a Fraud Alert on your credit report. That company must communicate your request to the other two CRAs. An Initial Fraud Alert can make it harder for an identity thief to open more accounts in your name. The alert lasts 90 days but you can renew it.
- \*Consider "freezing" your credit, a process that allows you to make your credit unviewable to anyone, even to legitimate sources, until you specifically "thaw" it. Be aware that credit freeze laws vary by state, and commonly have fees. Equifax is waiving its fees until 01/31/18.
- \*Pull your credit every four months via <a href="https://www.annualcreditreport.com/index.action">https://www.annualcreditreport.com/index.action</a>. The site provides one free credit report per CRA per year. There is a cost if you want your credit score, but the relevant ID and account information is all cost free. This site does NOT create a credit inquiry and therefore does NOT lower your credit score.
- \*Consider a subscription to a credit monitoring service.
- \*Utilize free Alert functionality wherever possible with your credit cards, bank accounts, etc.
- \*Utilize two phase authentication wherever possible. When logging to an account, this sends a temporary code to your specific email address or cell phone, which you then authenticate by entering it to log in.
- \*Vigilantly monitor all financial statements for misuse. Identity theft experts say to watch for micro withdrawals/purchases from your deposit and credit card accounts, as this is a sign of a thief probing your account so they can make a major move later.
- \*Consider adjusting your tax withholdings to reduce or eliminate a potential tax return to mitigate the risk of someone filing a false return in your name

Data breaches like this are unfortunately becoming more common, and it is more important than ever to protect your information.
